B.C.A NEP-2020 અભ્યાસક્રમમાં પ્રવેશનાધોરણો - નિયમો
જૂન ૨૦૨૫ થી શરૂ થતા શૈક્ષણિક વર્ષ માટે

(1) Admission Eligibility:

To secure admission in the first year of B.C.A., the candidate must have passed the Higher Secondary School Certificate Examination (Standard 12 in any Stream with English Subject) conducted by the Gujarat Secondary Education Board or the Central Board of Secondary Education (CBSE), **OR** must have passed an equivalent Diploma or ITI (NCVT/GCVT Certificate) examination recognized by the Government of Gujarat or by any statutory Board recognized by the State or Central Government which is considered equivalent to the Higher Secondary School Certificate Examination.

(2) Regarding the Merit List:

For admission to the First Semester, based on the applications received within the stipulated time and following the prescribed rules, a merit list will be prepared **from the Total Percentage obtained in** the Higher Secondary Examination by the candidates. In addition to the General category, **separate merit lists** shall be prepared for SC, ST, SEBC (OBC-Bakshi), Physically Challenged (Divyang) candidates, children of ex/current defence personnel, Nomadic & Denotified tribes, Economically Weaker Section (EWS), If a candidate **did not pass the Standard 12 examination in the first attempt** but passed it in more than one attempt, then **2% per additional attempt shall be deducted**. In case of a **tie** in Standard 12 percentage, Marks of English in Standard 12 will be considered, and in the case of tie in English also, then the Standard 10 percentage will be taken into consideration.

(3) Allocation of Seats:

1. Admissions shall be granted **only up to the number of seats** (sanctioned division by Hemchandracharya North Gujarat University, Patan and AICTE).
2. Reserved seats shall be allocated according to the State Government's rules, as revised from time to time.
In the admission list, **non-reserved seats (GEN)** shall be filled **first** based on the merit order. If reserved-category candidates appear in this general merit order, **their admissions will be considered as GEN and not be counted against the reserved seats**.

(4) Reserved Seats (Reserve Seats):

For students who are **original residents of Gujarat**, seats have been reserved under the prevailing provisions of the State Government as follows:

No.	Category	Reservation Percentage
1	Scheduled Caste (SC)	7%
2	Scheduled Tribe (ST)	15%
3	Socially and Educationally Backward Classes (SEBC)	27%
4	Children of Ex-Servicemen / Serving Defense Personnel (Ex-Service Man)	1% Supernumerary Seats
5	Physically Challenged (Divyang) – (PC)	5% (Within Category) with more than 40% Disability

6	EWS (Economically Weaker Section)	10% (33% out of this 10% for Girls)
7.	Sports/ Cultural Quota	2% Supernumerary Seats

1. In the admission list, if SC/ST/OBC category applicants fall under the General category based on their merit, they will be considered in the General category **as well as** they may take admission under whichever category seat (General or their own reserved category) they are allotted. If they choose admission under the reserved category seat, they will **not lose** their right to the seat they would have earned under the General merit.
2. If **no SC applicants** are available and SC seats remain vacant, those seats may be filled from ST applicants, and **if no ST applicants** are available and ST seats remain vacant, those seats may be filled from SC applicants. Even after this, if seats remain vacant for both SC and ST categories, they will be filled from the General category.
3. Applicants **seeking the benefit of reserved seats** must attach a caste or category certificate issued by a competent authority along with their application; otherwise, their application will be considered only for the **General** category.
4. For applicants from socially and Educationally Backward Classes (OBC), a valid OBC certificate issued by a competent authority **after 01/04/2022**, indicating that they do not belong to the Creamy Layer (and valid for three years or as specified in the certificate), must be attached. Otherwise, their application will be considered only for the General category.
5. **EWS (Economically Weaker Section)** non-reserved category students must submit a valid certificate from a competent authority along with the application.

(5) Reservation for the Physically Challenged (Divyang):

1. For Divyang (physically challenged) candidates, **5% of seats** in each category (General, SC, ST, and OBC) shall be reserved.
2. Divyang candidates must obtain a certificate from a Civil Surgeon (or a Resident Medical Officer if there is no Civil Surgeon) stating **more than 40% disability**, and attach it with the application.
3. The **1%** sub-reservation for the blind or visually impaired does **not** automatically include them under Divyang. Such applicants should write “Blind/Visually Impaired Candidate” on their application. They must attach a certificate regarding their blindness/visual impairment from the Civil Surgeon. As per **Section 2(B) of Chapter 1 of the Disability Act, 1995**, along with the application.

(6) Reservation for Children of Current/Ex-Defence Personnel:

1% of seats shall be reserved for children of **serving or ex-servicemen** of the Central Government’s military and paramilitary forces and also for such personnel of the Gujarat State forces. Such applicants must attach a **recent (latest) certificate** from a competent authority (such as the District Ex-Servicemen’s Welfare Board) confirming they are children of serving or ex-defence personnel. Otherwise, they will be considered under the General category.

(7) Regarding Fees:

Students shall be required to pay the fees determined by the Government of Gujarat and the University.
